I, THE UNDERSIGNED, hereby offer to hire from The Marconiphone Company Limited, 100, Blyth Road, Hayes, Middlesex (hereinafter called "the Company") the apparatus described herein and hereinafter called "the equipment" on the following terms and conditions which will become binding upon the Company giving me written notice of their acceptance within 21 days of the receipt by them of this offer:—

(b) Monthly payment
(c) Total Hire

- 1. I will pay to the Company by way of rent in advance for the hire of the equipment:
 - (a) a first payment of (a) £ : on the date hereof, and
 - (b) the sum of (b) £ : : on the day of every subsequent calendar month throughout the continuance of the hiring and until the sum of (c) £ : : shall have been paid or until this Agreement shall be determined in pursuance of the provisions hereinafter contained, all such payments to be made to the Company without previous demand at the address appointed by the Company in writing from time to time.
- 2. I will during the continuance of the hiring keep the equipment in my own custody at my address herein mentioned or at such other place as may previous to removal be authorised in writing by the Company and I will not sell, assign, pledge or otherwise part with the possession of the equipment or any part of it and will duly and punctually pay all rents, rates and taxes payable in respect of the premises in which the equipment may for the time being be placed and will produce to the Company on demand the receipt for the last payment due in respect of such rents, rates and taxes respectively.
- 3. I will during the continuance of the hiring use the equipment in a careful and proper manner and will at my own expense keep it in good and complete repair, order and condition. All valves, batteries and accumulators comprising part of the equipment will be repaired or replaced at my own expense when necessary and I hereby indemnify the Company against all loss or damage to the equipment from whatever cause arising, destruction or damage by fire alone excepted.
- 4. I agree that the Company may if it become in its opinion necessary, exchange or authorise exchange of the equipment for other equipment of similar type and such substituted equipment shall be subject to the full terms and conditions of this Agreement.

- 6. I will permit the Company and all persons authorised by it at all reasonable times to enter upon the said premises where the equipment may for the time being be placed to inspect the state and condition thereof.

I may at any time during the hiring become the purchaser of the equipment by paying to the Company such a sum as together with previous payments by way of hire rent shall make the full sum of (c) £ : : and I shall be allowed on such additional sum a discount of 5 per cent., and thereupon the equipment shall become my property, but until all such payments as aforesaid have been made the equipment shall remain the property of the Company.

If I terminate the hiring under Clause 8 before six months from the date hereof I will pay to the Company by way of compensation for depreciation in value of the equipment, such a sum, if any, as with the sums then and previously paid for hire rent shall be required to make up a sum equal to 50 per cent. of the sum of (c) £ : payable as hire under Clause 1
- 10. In case I shall make default in effectual payment in full on due date of any sums to be paid by me hereunder for hire rent or shall fail to observe and perform the terms and conditions of this Agreement on my part to be observed and performed or shall do or cause to be done or permit or suffer any act or thing whereby the Company's rights in the equipment shall or may be prejudiced or put in jeopardy or become bankrupt or enter into any composition with my creditors it shall be lawful for the Company to retake possession of the equipment and for that purpose I give to the Company leave, consent and licence to enter by itself or its duly authorised representatives into or upon any premises in which the said equipment or any part thereof shall be or be supposed to be.
